    - third-party business partners and affiliates using Personal Information about you to identify goods and services in which you may be interested.

  - obtaining your views on our goods, services and Website/Fluro Platform (available to Fluro Borrowers);
  - analysing the effectiveness of our ads, promotions and offers;
  - conducting testing of our systems, Website, Platform and other operations; and
  - performing statistical analysis and/or conducting wider market research.

- 6.4. You acknowledge and agree that we will not be able to retrieve any Personal Information we have sent to any third parties based on your initial consent.
